I hereby release the Rio Bravo Ranch and Nickel Family LLC, its officers, directors, owners, employees and agents from any and all liability, which may hereinafter develop or accrue because of any injury, loss or damage which may be suffered by me. I will be on ground that may be uneven, contain holes, dips, rocks and other materials or animals, giving rise to a potential for injury. Furthermore, the ground and surrounding areas itself are potentially injurious. Rio Bravo Ranch is a working farm and, therefore, has equipment operating on various portions of the property. Also, at various times, the owners and/or their guests may hunt for game on the property with rifles and/or shotguns. Additional dangers that might be encountered on the Rio Bravo Ranch are wildfires, rattlesnakes, overhanging branches, cliffs, coyotes, bobcats, mountain lions and deer. I further acknowledge that water in troughs, irrigation lines, streams and ponds on the Rio Bravo Ranch are untreated and should not be consumed.

I hereby assume and accept the full risk and danger of any harm, injury or damage which may occur through or by reason of any matter, thing or condition, negligence or fault, of any person or persons whatsoever. Furthermore, this Release extends to any personal representatives, assigns and heirs and next of kin for any loss or damage or claim or demands on account of any injury or property damage or death of the undersigned, whether caused by the negligence of the Releasees or otherwise.

There may be cattle and/or sheep grazing on various portions of the Rio Bravo Ranch property. The undersigned hereby agrees not to interfere with the grazing operations, and agrees to be responsible for any damages caused to the grazing livestock by the undersigned.

The undersigned expressly agrees that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the laws of the State of California and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Additional Conditions: No pets or outside food is allowed on the premises for any reason.
